NSSDC RACE RULES APPLY

Waiver for Race Racers

By signing below, you agree, warrant and covenant as follows:

I ACKNOWLEDGE THAT BY SIGNING THIS DOCUMENT, I AM RELEASING MIDWEST MOUNTAINEERING, THE CITY OF HAM LAKE, THE HAM LAKE CHAMBER OF COMMERCE, MIDWEST SKIJORERS CLUB AND THEIR RESPECTIVE AGENTS, EMPLOYEES, MEMBERS, SPONSORS, PROMOTERS AND AFFILIATES (COLLECTIVELY "RELEASEES") FROM LIABILITY. THIS ENTRY BLANK AND RELEASE IS A CONTRACT WITH LEGAL CONSEQUENCES. I HAVE BEEN ADVISED TO READ IT CAREFULLY BEFORE SIGNING.

In consideration of the Releasees acceptance of my application for entry in the 2010 PUPPY LOVE event, I hereby freely agree to and make the following contractual representations and agreements.

I acknowledge that dog powered sports are inherently dangerous sports and fully realize the dangers of participating in a dog powered sports race, and FULLY ASSUME THE RISKS ASSOCIATED WITH SUCH PARTICIPATION INCLUDING, by way of example, and not limitation, the following: the dangers of collision with other racers and their dog teams, trees, vehicles, and other fixed or moving objects; the dangers arising from surface hazards, equipment failure, inadequate safety equipment, the dangers of injury to myself and dog team from dog fights or other dog/dog or dog/human interaction; THE RELEASEES' OWN NEGLIGENCE, and weather conditions; and the possibility of serious physical and/or mental trauma or injury associated with dog powered sports competition. For myself, my heirs, executors, administrators, legal representatives, assignees, and successors in interest (collectively "Successors") I HEREBY WAIVE, RELEASE, DISCHARGE, HOLD HARMLESS, AND PROMISE TO INDEMNIFY AND NOT TO SUE the Releasees and the sponsors of this event, the organizer and any promoting organizations, property owners, law enforcement agencies, all public entities, special districts and properties, and their respective agents, officials, and employees through or by which the event will be held, (the foregoing are also collectively deemed to be Releasees), FROM ANY and all rights and CLAIMS INCLUDING CLAIMS ARISING FROM THE RELEASEES' OWN NEGLIGENCE, which I have or which may hereafter accrue to me and from any and all damages which may be sustained by me directly or indirectly in connection with, or arising out of, my participation in or association with the event, or travel to or return from the event. I agree it is my sole responsibility to be familiar with the racecourse, the Releasee's rules, and any special regulations for the event. I understand and agree that situations may arise during the race, which may be beyond the control of the race officials or organizers, and I understand I am responsible for neither endangering others nor myself. I accept responsibility for the condition and adequacy of my competition equipment and dogs. I have no physical or medical condition, which to my knowledge, would endanger others or myself if I participate in this event, or would interfere with my ability to participate in this event. I understand that I may not use any performance enhancing drugs of any kind to increase my athletic performance or that of my dog team, and that I must treat my dogs and other skijor dogs I may come in contact with during the course of the event humanely at all times. I also understand my personal behavior must be without exception RESPECTFUL AND POSITIVE to reflect favorably on dog powered sports and this event. Failure to abide by these rules will result in immediate disqualification by the Chief race official. I agree, for myself and my successors, that the above representations are contractually binding, and are not mere recitals, and that should I or my successors assert my claim in contravention of this agreement, the asserting party shall be liable for the expenses (including legal fees) incurred by the other party or parties in defending, unless the other party or parties are finally adjudged liable on such claim for willful and wanton negligence. This agreement may not be modified orally, and a waiver of any provision shall not be construed as a modification of any other provision herein or as consent to any subsequent waiver or modification. Every term and provision of this agreement is intended to be severable. If any one or more of them is found to be unenforceable or invalid, that shall not affect the other terms and provisions, which shall remain binding and enforceable.

I agree to let MIDWEST SKIJORERS and race sponsors use photographs or videos from the event in any promotional material.
